

Internally Marked Assessments and Reviews of Marking

Coursework/Controlled Assessment and Non-Exam Assessment (NEA) GCSE/GCE

Dear Student/Parent

You have undertaken coursework, a controlled assessment or other non-examined assessment (NEA) as a part of a GCSE or A Level course. The subject teacher will mark this work and your mark will then be sent to the appropriate examination boards. The examination board will review the mark, which will then go towards determining your final subject grade.

If you have reason to believe that your work has not been marked correctly then you will have an opportunity to request an internal review before marks are sent to the examination board.

Before requesting a review you will have an opportunity to examine all the material related to marking (e.g. your own work, the mark scheme).

If, after examining these materials, you request a review and your request is accepted, then your work will be re-marked by an independent marker. This may be another of the tutors in the subject here at Fine Arts College. If there is only one tutor in the subject here, the work and the marking will be reviewed by a subject tutor at one of our sister colleges within the Dukes Education group.

Your mark may increase, decrease or stay the same as the result of a review, but that mark will be final (i.e. you cannot go back to your original mark or request a further review).

You may like to discuss this matter with a parent or carer before proceeding with a request to review. After examining all of the available materials, you must complete a **Centre Assessed Mark Review Request Form**, giving full details of why you feel your mark is incorrect and return the form to mail@hampsteadfinearts.com.

The form must be returned by the deadline see attached list of deadlines for review requests in each subject. You will be notified in writing of the outcome and your final mark will then be sent to the examination board.
